

We also had the privilege of welcoming arc flash survivor Rodney Walker, who delivered a powerful seminar highlighting the daily dangers faced by our field crews and the critical importance of proper personal protective equipment (PPE). This event was a collaborative effort with our local municipal partners from Chicopee, Holyoke, and South Hadley, reinforcing our shared commitment to safety in the communities we serve. Spring is the perfect time for a little home maintenance. Start by checking your carbon monoxide (CO) and smoke detectors and replacing the batteries to ensure they're working properly. We suggest doing this in the spring and fall, when you change the clocks forward and back. It's also a good habit to change your air filters regularly. Dirty filters force your heating and cooling systems to working harder, using more energy to run which can increase your utility bill. Most filters should be replaced every three months, or even more if you have pets. And before that first heat wave, consider scheduling a professional tuneup to catch potential issues early and keep your home comfortable all year-round.

For those planning outdoor projects, don't forget to **call 811 before you dig** for your own safety and to prevent damage to underground utilities. Whether you're planting a tree, installing a fence, or starting a larger landscaping project, underground utilities may be closer to the surface than you think. Please review the 811 section in this flyer for more information about how to complete your digging project without unexpected hazards. Thank you for your help in keeping Westfield safe.
